

Privacy Statement –

To register and participate in this drawing, and other Lottery promotions and surveys, you must provide some personal information such as your name, ZIP code, e-mail address and/or telephone number so that Lottery can contact you. We collect no personal information about you unless you voluntarily provide it to us. If you win a prize, we may use your name and the city where you live in a Lottery promotional campaign, advertisement, or press release. You should be aware that although we do not generally disclose personal information to others, all information collected at this site becomes a public record under Oregon's Public Records Law, ORS 192.410 to 192.505 and may be subject to inspection and copying by the public. We will be required to disclose your personal information if ordered by a court or the Attorney General, or if otherwise required by law.

How to Play

You can enter via <http://www.oregonlottery.org/GameInfo/Promos/PromotionalDrawings.aspx>. No purchase is necessary. Once you have enrolled, you are automatically entered for any of the remaining drawings.

The time frame of received entries will be posted on <http://www.oregonlottery.org/GameInfo/Promos/PromotionalDrawings.aspx> otherwise; the entries will be accepted through the fourth Wednesday of the month, until 4:30 p.m. PST.

You must be 18 years of age or older at the time of entry and provide the following: full name, ZIP code, e-mail address and/or phone number, so we can contact you if you win.

Refer 5 Friends and Get Additional Entries

Each month you have a chance to earn more entries by referring up to 5 friends. Receive 1 additional entry for each friend that enrolls during that month. That could give you 6 entries (1 monthly entry plus up to 5 referred entries) if all of your friends enroll in that month.

Prizes Description

The monthly quantity of winner(s), monthly prize option(s), and equivalent cash value of the prize(s) will be listed on the <http://www.oregonlottery.org/GameInfo/Promos/PromotionalDrawings.aspx> web site. Winner(s) will be able to select one prize from the monthly prize option(s). For example, if the prize quantity is limited, the first winner to claim the prize will be awarded the limited prize leaving the other monthly prize option(s) available to the remaining winner(s). Or, if a prize has an expiration and is not chosen or claimed promptly, the expiration prize can be given away leaving the other monthly prize option(s) available to the remaining winner(s).

Drawing Details

There will be a random number generator (RNG) drawing(s) selecting the monthly quantity of winner(s) and if needed alternate(s). Odds of winning depend on the total number of entries received.

A drawing date will be held on or around the fourth Thursday of each month for the life of this promotion unless specified differently on the <http://www.oregonlottery.org/GameInfo/Promos/PromotionalDrawings.aspx>. The drawings will be conducted at the Lottery Headquarters in Salem, Oregon.

Notification of Winner

- Winner(s) notification will happen no later than the week following the drawing.
- The Oregon State Lottery will notify the winner(s) by e-mail or phone.
- The winner(s) will have 14 calendar days from the date of notification to claim the prize.

Prize Claim Rules

- Winner(s) may claim the prize:
 - in person at the Lottery Headquarters in Salem, Oregon ,
 - access the Oregon Lottery web site <https://w9.oregonlottery.org/> , or
 - request to receive the W-9 form by mail.

- A prize containing a live ticket(s) will only be mailed to an Oregon address.
- Must be 21 years of age or older to claim a prize related to or containing alcohol.
- Only prizes claimed will be awarded.

Prize Taxes

- Lottery will not pay any additional fees or expenses including, but not limited to, hotel taxes or fees, travel agent fees, or any other taxes, fees, or expenses that the winner may incur.
- As of January 1, 2011, anyone who wins a promotional prize valued at over \$25 will be required to fill out a form that tracks promotional prize winnings. A Social Security Number is required in order to claim any promotional prize valued over \$25. If you are unable or unwilling to provide a Social Security Number, you are ineligible to receive a promotional prize(s). By the end of the calendar year if the total value of promotional prize(s) won by any individual is \$600 or more, a 1099 form will be issued for tax reporting purposes.

Disclosure Requirement: To receive a promotional prize the winner shall furnish to the Lottery the information required on the Internal Revenue Service Form W-9 (or any other form required by the IRS), including but not limited to the winner's name, address, and social security number. This disclosure is mandatory and the authority for such disclosure is 42 USC 405 (c) (2) (C), 26 CFR 31.3402 (q)-1(e), and ORS 461.715(1)(a). A winner's social security number will be used for the purpose of submitting required documents to state and federal tax authorities. (Retailer Promotions: Current Lottery Retailers are not subject to this requirement because the Lottery has the necessary information for current Lottery Retailers. Promotional prize(s) will be included with the Lottery Retailer's yearly 1099 informational return.)

- The winner is responsible for all applicable taxes unless otherwise stated by the Oregon Lottery.
